TERMS & CONDITIONS

Before submitting your works to the The Teddy Bear Competition please read these Terms & Conditions carefully. If your works do not meet the entry specifications, as stated in the Terms & Conditions, they will not be included in the exhibition.

Entry fee refunds will not be provided if your work does not meet the specifications outlined below. All artworks must measure 297 mm x 420 mm exactly.

You can enter up to 2 works.

Artworks on paper. Artworks must be completed in 2024.

We accept only 2-dimensional.

All entries to the The Teddy Bear Competition must be completed online via www.gallerylenuancier.com.au,

Visit our Online Entry Step by Step Guide for assistance.

Artworks entered the prize via our website must be the same as the works received for display. Artworks cannot be removed during the exhibition period. This prize is open to age 5 to age 18. By entering this prize artists are confirming they are the creator and owner of the entered work(s) and have not breached copyright in the creation of the work, The work has been created without the help of an adult person. Failure to comply with any of the above will make an entry ineligible, Placement of the works in the exhibition is at Gallery Lenuancier's discretion. An exhibition will be held during a Teddy Bear Picnic in February 2025.

ENTRY FEES

\$15 for one work, \$30 for two works including GST

Entry fee(s) are non-refundable and cover administration, return postage and handling ENTRIES CLOSE

Midnight Friday 2nd August 2024

The number of entries will be capped at 1000 artworks. These places may fill up before the entry deadline.

ARTWORK arriving BY POST

Between Monday 2nd September and Monday 16th September 2024.

Otherwise they can be delivered in person at the Gallery opening hours.

EXHIBITION DATES of prize winners will be on Saturday October 12 2024 at 6.30pm. The Teddy Bear prizes will be handed to the winners on that day,

A Teddy bear picnic will be held in February 2025 and all artworks will be on display.

RIGHT TO REFUSE TO DISPLAY ARTWORKS

Gallery leNuancier reserves the right to refuse to display artwork if it:

Does not meet entry requirements.

Is not exactly 297 mm x 420 mm in size.

Poses safety risks.

Under normally accepted standards, could be considered offensive in terms of pornographic content, character denigration, racial or religious prejudice.

Is considered by relevant Indigenous Traditional Owners to be disrespectful or exploitative of their culture and heritage, or if the appropriate consultation has not been undertaken in the making of the

Work, or if the Work is otherwise in contravention of the Australia Council for the Arts' Protocols for Using First Nations Cultural and Intellectual Property in the Arts.

In any way does not comply with Gallery lenuancier's policies and procedures.

The judges will award all prizes and their decisions are final and no correspondence will be entered. Prizes will be announced on Saturday October 7 2024..

POSTAGE AND INSURANCE

All artworks are packaged for return to artists by Australia Post at no additional cost to the artist (this is covered by the entry fee). They are returned within 14 – 21 days after the completion of the exhibition. Gallery lenuancier will not be held responsible for any loss or damage caused to any work while in transit to and from the gallery. All artworks will be handled by experienced staff. However, fragile works will be entered at artist's own risk. Gallery lenuancier's insurance will cover works whilst on display at the gallery. Please ensure that you contact gallery staff if you move from the address provided. If you are going to be away please ensure you have a hold on your post so that no packages go missing.
